## Minutes, Notes, and Happening of last months' meeting

Last month's meeting was held on Tuesday August 11<sup>th</sup>. We had 15 members in attendance.

President Dave F. called the meeting to order at 7:01.

Dave had various coin magazines, Coin World's, and Greysheets to borrow this month.

Dave reviewed some interesting articles.

- US Mint stopped minting ASE for a while. Resumed July 27th.

- In the US Government verses the Langbords' case, the Government filed for a rehearing and it was granted.

- The Native American dollar dated 2015 are being minted at West Point with an enhanced uncirculated strike. Will be packaged with a 2015-P Sacagawea dollar and an 2013 Federal Reserve Note.

- A treasure recovery off of Florida found 12 galleons and some gold coins.

Dave reviewed the past coin shows. The Greeley show was SLOW, even for Greeley.

Dave then reported on upcoming Coin Shows.

Dave reviewed the Door Prizes, Raffle, and Coin of the Month for this meeting.

A motion was made and seconded to approve the minutes that were in the July Newsletter.

## Last Months' Show and Tell Recap

Joann L. brought in a Mardi Gras token from 1975. It said "Hoot and Holler Hillbilly" on it. These were tossed during Mardi Gras in New Orleans. Ones from the 60's can be valuable.

Terry S. had a 1932 "Rare Coin Encyclopedia" book with interesting prices. The 1909 Lincoln cents did not list mintmarks or VDB varieties.

Michael S. had a Seated Half Dollar in an ANACS slab that re-engraved shield lines. Also had an 1861-O Half dollar that had a metal blob on the nose due to a die crack that indicated that it was minted by the Confederacy after they took over the mint. This was verified by ANACS.

Dave F. brought in some German coins. These had been tough to attribute. Finally showed them to someone at Summer Seminar, who gave him an idea on what book to look at to attribute them. Dave found the book in the ANA Library and was able figure out what they were. They were minted between 1024 and 1029.
