SHOW & TELL

Dave F. showed a few items he obtained at the NY International Coin show. A 1733 Austrian Thaler, a 1735 Groschen, and a 1724 Ducat for the Netherlands. Don K. had a 1907 stock certificate that was from the Lee Comstock Mining Company in Nevada, along with an original brochure that was used to try to sell the stock certificates. Tim Z. brought in some Chinese counterfeit coins. These coins were counterfeits of coins from China and not of US coins.

PROGRAM – Dan Carr gave a presentation on his Moonlight Mint. Dan designed the New York and Rhode Island state quarters. His presentation was the story of how he obtained an actual coin press that was previously used at the Denver Mint. He had a pictorial history of the press and the condition it was in when he obtained it and a step by step of how he restored it to operational condition. He had picture of various blank planchets he found in various crevices in the press. He told of how he created his own die and used all the blank planchets to mint special tokens commemorating his operational press. Dan also showed pictures of a 1964-D Peace dollar he made with the press. He made his own die and then used a actual Peace dollar to strike his 64 Peace dollar.

The "Coin of the Month". Buffalo nickels were the Coin of the Month. Michael E. won a pot of 6 Buffalo coins.
