The program in September was "Lesher Referendum Dollars in Colorado" given by NSCC Member John B. John gave some history on Joseph Lesher and how these Silver "Dollars" came to be. They were intended to promote the use of Silver, and attempt to raise the price of silver, mined in the Cripple Creek/Victor area, by the local merchants and residents as a type of trade token. They were produced around 1900-1901. John also discussed the various varieties that came to exist. John indicated a good book on the subject is "Forgotten Colorado Silver Coins" by Andna G, Wilde Jr., Kenneth Hallenbeck, and Robert D. Leonard Jr.

President's Notes

Northside Coin Club Meeting October 13th, 2020

News Items

1. Market Analysis: Magnificent error coins bring big money, Coin World, September 10, 2020. Story Summary: Among the spectacular errors traded in August at the big auctions by Heritage and Stack's Bowers Galleries was an 1891 Seated Liberty quarter dollar that was dramatically double struck, with the second strike 50 percent off center. It was graded Mint State 62 by Numismatic Guaranty Corp. The coin rotated 90 degrees clockwise between strikes. No planchet was fed between strikes, thus both sides show the dramatic widely off-center second strike. Both dates are clearly visible, and the result is a impressive double-strike error from the Philadelphia Mint that is rarely seen on this 19th century type. Heritage found no direct comparables in its research of errors on Seated Liberty quarter dollar.

2. Colorization contract suggests possibility of additional colorful coins, medals, Coin World, August 21, 2020. Terms of the contract the U.S. Mint awarded LulaRose on Oct. 9, 2019, to colorize Proof 2020 Basketball Hall of Fame silver dollars and clad half dollars suggest the Mint is seeking to extend the colorization technology to multiple other series options, including gold coins, and silver and bronze medals. The United States Mint may have multiple coin programs per calendar year that could require colorization, from one to five, according to the contract. The contract also addresses the capability of colorizing coins struck on square planchets. The U.S. Mint has never produced a coin on a square planchet. The base contract is for a one-year period, ending Sept. 30, 2020, with the possibility of the Mint exercising up to four one-year contract extensions, running through Sept. 30, 2024.

(tails) designs for bullion and collectible versions of American Eagle Gold and Silver Coins. 2021 marks the 35th Anniversary of the American Eagle Coin Program, and the new designs will begin appearing on these coins in midyear 2021.

5. NGC Ancients Certifies Fabled "EID MAR" Aureus of Brutus, NGC News, October 8, 2020. Perhaps the most important and valuable Roman coin ever to be offered at auction — an 'EID MAR' aureus of Brutus in Mint State condition — has been certified by NGC Ancients. This remarkable example of one of the rarest ancient coins in existence is being offered by Roma Numismatics Limited, a United Kingdombased specialist, in a sale ending October 29. While there are about one hundred silver examples of the EID MAR, only two gold pieces were known until now.

The Mints' production during its' first year was 145,846 coins in Half Cents and Cents to be used in circulation. Today the Mint produces over 12 billion coins for circulation. This consists of cents, nickels, dimes, and quarters and does not even include the half dollar and dollar coins which some feel do not really "circulate".
